## DANGER

### READ LABEL BEFORE USE

An approved Wool Marketing Material Pursuant to the NZ Animal Act (1967).

### DIRECTIONS FOR USE

Shake the can well. Hold upright. Spray with nozzle close to the animal. Avoid heavy application. Do not overspray. Apply only to head or tail. Avoid marking prior to shearing.

### HAZARD STATEMENTS

Extremely flammable aerosol. Pressurised container: May burst if heated. Highly flammable liquid and vapour. Causes skin irritation. May cause drowsiness or dizziness. May be fatal if swallowed and enters airways. Very toxic to aquatic life with long lasting effects.

### PREVENTION STATEMENTS

Keep out of reach of children. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. Do not spray on an open flame or other ignition source. No smoking. Take precautionary measures against static discharge. Leaking gas fire: Do not extinguish, unless leak can be stopped safely. Eliminate all ignition sources if safe to do so. Protect from sunlight. Avoid breathing fume/gas/mist/vapours/spray. Avoid release to the environment. Wear protective gloves/protective clothing/eye protection/face protection.

### RESPONSE STATEMENTS

If medical advice is needed, have product container or label at hand. IF SWALLOWED: Immediately call

a POISON CENTER/doctor. Do NOT induce vomiting. IF ON SKIN: Wash with plenty of soap and water. If skin irritation occurs: Get medical advice/attention. IF INHALED: Remove to fresh air and keep at rest in a position comfortable for breathing. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention. IF UNWELL: Call a POISON CENTRE or doctor. Wash contaminated clothing before use. Additional information is listed in the safety data sheet.

### STORAGE STATEMENTS

Store in a well ventilated place. Protect from sunlight. Do not expose to temperatures exceeding 50°C/122°F.

### DISPOSAL STATEMENTS
