GENERAL INFORMATION

TRAKKA BRITE is a red liquid marker dye to assist in clearly identifying sprayed areas. Use of **TRAKKA BRITE** helps to minimise the problems and losses associated with missed coverage and double overlap spraying. When used as a colouring agent with **TRAKKA Long Life Marker Foam**, foam will become pink in colour making it easier to see.

RECOMMENDATIONS:

USE	RATE	COMMENTS
Knapsack Sprayer	3 - 7 ml/10 litres of spray solution	Use higher rate if more intense colour is required.
Handgun and Boom spray rigs	30 - 70 ml/100 Litres of spray solution	When used with glyphosate, phenoxy or sulphonyl urea herbicides take extra care to follow the mixing order and instructions and add TRAKKA BRITE to the tank last after the herbicides are thoroughly mixed. Failure to do so may result in incompatibility and blocked nozzles.
Addition to TRAKKA Long Life Marker Foam	40-80ml/100 Litres of diluted foam solution	Converts white foam to pale or deep red (higher rate for deeper colour) for clearer identification on pale surfaces.

MIXING INSTRUCTIONS

Half fill the spray tank and add agrichemical products with agitation operating. Continue to fill the spray tank until nearly full, then add the required amount of **TRAKKA BRITE**. Maintain agitation until spraying is complete. For Knapsack sprayers, follow the same mixing order and ensure that the product/s used are thoroughly mixed before adding **TRAKKA BRITE**.

COMPATIBILITY: CAUTION: Use with some formulations of certain agrichemicals such as phenoxy herbicides and glyphosate can cause incompatibility that will lead to blocked spray nozzles. For use with these products **TRAKKA RED** is recommended.

SPRAYER CLEAN UP: Wash out all spray equipment thoroughly after use as product residues can cause discolouration of subsequent sprays
