Call the Fire Service: Dial 111. Wear PVC protective clothing and breathing apparatus. Extinguish fires with water Fire fog, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off.
