HAZARD STATEMENTS

Flammable liquid and vapour. Causes skin irritation. Causes serious eye irritation. May cause an allergic skin reaction. May cause damage to organs (single exposure). May cause damage to organs through prolonged or repeated exposure.

PREVENTION STATEMENTS

Read label and Safety Data Sheet before use. Keep away from heat. No smoking. Keep container tightly closed. Ground/bond container and receiving equipment. Use explosion proof ventilating equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe vapours. Wash hands thoroughly after handling. Do not eat drink or smoke while using this product. Contaminated work clothing should not be allowed out of the workplace. Avoid release to the environment. Wear protective gloves and eye/face protection.

RESPONSE STATEMENTS

IF ON SKIN: Wash with plenty of soap and water. IF ON SKIN (or hair): Remove immediately all contaminated clothing.

Rinse skin with water. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if you feel unwell. If skin irritation or rash occurs: Get medical attention. If eye irritation persists: Get medical attention. Take off contaminated clothing and wash before reuse. Collect spillage.

STORAGE STATEMENTS

Store in a well ventilated place. Keep cool. Store locked up.

DISPOSAL STATEMENTS

Dispose of product or empty containers safely. Avoid contamination of any water supply with product or empty container. Ethanol: Land Spill - Apply appropriate foam to diminish vapour and fire hazard. Water spill - Use natural barriers or oil spill control booms to limit spill travel. Allow to aerate. Air spill - Apply water spray or mist to knock down vapours.
