| IF THIS HAPPENS | DO THIS |
|-------------------------|---|
| Vehicle accident | Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services on 111. |
| Spill or leak | In case of spillage wear appropriate protective clothing and prevent material from entering water ways. Absorb spills with inert material and place in waste containers. Wash area with water and absorb with further inert material. Dispose of waste safely. Avoid contamination of any water supply with product or empty container. Avoid release to the environment. |
| Fire | Call the Fire Service on 111. Keep non-involved persons clear. Product is not flammable. Wear PVC protective clothing and breathing apparatus. Extinguish fires using water spray/fog, foam, dry chemical or carbon dioxide. Contain runoff and treat as for Spillage above. |

FIRST AID

| If swallowed | DO NOT induce vomiting. For advice contact a doctor or the National Poisons Centre on 0800 POISON (0800 764766), or a doctor immediately. |
| If in eyes | Hold eyelids apart and flush continuously with running water for at least 5 minutes. Get medical attention. |
| If on skin | Remove contaminated clothing, flush skin with running water. Do not scrub skin. |
| If inhaled | Remove affected person to fresh air. Get medical attention for any symptoms that develop. |

STORAGE AND SEGREGATION

Storage: Store below 25°C (Room temperature) in tightly closed original container in a dry, well-ventilated and secure area when not in use. Keep out of reach of children.

Aggregate Storage Volume Thresholds: When stored with substances of the same hazard the aggregate quantity must be considered. Refer to NZS8409 Management of Agrichemicals and the HSNO Regulations for full details.
